ITEM 1: WELCOME

- 1. <u>Opening.</u> Region 1 President, Hans Blondeel Timmerman, PB2T opened the meeting at 09:00. He welcomes the EC members and guests to the meeting in the most western part of Region 1. With help of the Tourist Board of the Azores a significant cost reduction has been made possible.
- 2. <u>Administrative Arrangements.</u> Dennis, ZS4BS gives feedback on the coffee breaks and lunch. The EC will visit the local radio club on Friday evening.
- 3. <u>Roll Call.</u> Dennis, ZS4BS, held roll call. Hani Raad, OD5TE, and IARU Region 3 tendered apologies.
- 4. <u>Approval of the Agenda.</u> The Agenda for the meeting is approved.
- 5. <u>Silent Keys.</u> The following silent keys were noted and the meeting paused for a moment of silence and remembrance. R.J. "Tim" Hughes, G3GVV; Hubert Walcott Benjamin Sr., EL2BA and John Huntoon, W1RW.

ITEM 2: 2013 EC MEETING

6. <u>Minutes of the previous meeting.</u> The minutes of the 2013 Region 1 EC meeting held in Reykjavik, Iceland on 4 and 5 May 2013 were published on the Region 1 web site and accepted as read. (Paper EC14_2.1)

 - a. None.

ITEM 3: EXTERNAL RELATIONS COMMITTEE

- 8. Colin, G3PSM, discussed the ERC report, Paper EC14 03.
 - a. <u>WG FM</u> Three meetings were attended by LZ1US and reports circulated. LZ1US represented IARU region 1 in Project Team 52 dealing with 2 300 2 400 MHz
 - b. <u>CEPT WGFM Civil/Military Meeting.</u> This group met in November 2013 and was attended by PB2T and LZ1US
 - c. <u>RAFG</u> Peter Frey, HB9MQM, continues to liaise with Alexander Gulyaev at the ECO following the ECO reorganisation. The RAFG is primarily a correspondence group under the umbrella of WGFM, however HB9MQM has travelled to Copenhagen and met with Alexander during this report period. It should be noted that Mr Gulyaev will be leaving his post during the summer of 2014.
 - d. <u>CPG</u> This is the CEPT top tier group dealing with ITU WRC matters and has held a further two meetings during this report period. Both meetings were attended by PB2T, as CEPT Coordinator for WRC-15 Agenda Item 1.4.
 - e. Working Group Spectrum Management (WGSE). G6JYB, continues to cover the work of this group particularly that of study group SE24 dealing with Short Range Devices (SRDs). Much of the work of this group has been carried out via web meetings however the following meetings were attended
 - a. 2,3 / 2,4 GHz MBANS
 - b. 5,7 GHz WIA Wireless Industrial Automation
 - c. WI50/51 on 77 GHz Helicopter and Fixed Infrastructure radars (which are drawing on WRC AI 1.18 moves)
 - d. <u>CPG Project A. AI 9.1.8 and AI 10.</u> This Project Team is dealing with two agenda items of interest to the amateur services A.I. 9.1.8 Regulatory aspects for nano and pico-satellites, and A.I. 10 Future WRC Agenda Items.
 - f. <u>CPG Project Team C.</u> CPG PT-C is dealing with WRC-15 Agenda Item 1.4: to consider possible new allocation to the amateur service on a secondary basis within the band 5 250 5 450 kHz in accordance with Resolution 649 (WRC 12) and Agenda item 1.18 to consider a primary allocation to the radiolocation service for automotive applications in the 77,5 78,0 GHz frequency band in accordance with Resolution 654 (WRC 12). PTC meetings were attended by PB2T
 - g. Working Party 1A (WP1A). G4FSU, attends this group as an IARU delegate. Work continues on establishing noise floor standards with ongoing talks between ITU-R and ITU-T. The annual meeting of this group took place in Geneva during June 2013. Peter Chadwick, G3RZP, has now retired from this work.
 - h. Working Party 5A (WP5A). The 5A1 Working Group on amateur matters is now chaired by Dale Hughes, VK1DSH. Recommendation ITU-R M. [VARICODE] Telegraphic alphabet for data

communication by phase shift keying at 31 baud, was finalized and approved by WP5A. This Recommendation now carries the designation M.2034. Work was also completed on updated the Amateur and Amateur Satellite Services Handbook which was still awaiting publication at the time of writing. It is hoped this document will soon be available as a free-of-charge download. Finally WP5A is responsible for drafting the CPM (Conference Preparatory Meeting) text for WRC-15 Agenda Item 1.4

- i. Work continues on Agenda Items 1.4 (5 MHz) and 1.18 (77,5 78,0 GHz). At this stage it is too early to forecast any outcome of ongoing discussions
- 9. <u>Panel of Experts Paper EC14_03.4.</u> All MS were contacted by G3PSM asking for nominations for Region 1 experts. Nominations received from ARSK, IRTS and PZK. The EC appoints David Court, EI3IO, and Enrico Li Perni, 5Z4ES, as IARU Region 1 experts. Brendan Minnish, EI6IZ, will be involved in standardisation under the EMC and/or PRC WG. The Secretary will send appointment papers to these members.

10. PB2T will contact PZK on their nomination.

- 11. Additional resources need to be found to support G6JYB in CEPT WGSE.
- 12. OE1MCU suggests that the Region 1 looks at having one person to attend meetings on an ongoing basis for continuity. The meeting sees the benefit of having one or two permanent representatives from IARU Region 1. However IARU Region 1 can't afford a full time professional. PB2T when handing over responsibilities to his successor (in October 2014) will further discuss this.
- 13. Member societies play an important role in the communication with administrations and Standardisation bodies. Where Member societies are not always in a position to fully understand the supporting documents it was suggested to provide an executive summary with the letter covering these documents.
- 14. WRC-15. There are two items of concern Al 1.4 and Al 1.18. Al 1.4 deals with a possible secondary allocation in the 5 MHz band PB2T gives an update. Al 1.18 deals with the use of automotive radar in the band 77,5 to 78,0 GHz. And Al 9.1.8
- 15. WRC-18/19. IARU Region 1 made a proposal to CEPT for future Agenda Items. The proposal covers allocations in the band 1800-2000 kHz, 50-52 MHz and 3400-3410 MHz. It should be noted that these proposal require the support of CEPT administrations.
- 16. CubeSats. ITU-R WP 7B studies regulatory aspects of small satellites. PB2T is the IARU representative
- 17. Regional Telecommunications Organisations. There are four RTOs in the Region: the Arab Spectrum Management Group; the African Telecommunications Union; CEPT and the RCC. The Region has inputs in three of the RTOs

ITEM 4: POLITICAL RELATIONS COMMITTEE

18. Thilo, DL9KCE, presented document EC_14_04 10.8 on the work of the PRC, including European policy (covered by DL9KCE), the Radio

Spectrum Policy Program (covered by G6JYB and ON4AVJ) and smart grid and - metering (covered by EI8BP). DL8DMA serves the PRC by searching a huge number of relevant internet sources.

- 19. The final versions of the EMC directive and Radio Equipment Directive were issued. In the next two years these directives will be converted into national law. Member Societies will need to keep a close look on this conversion. The PRC can help if needed.
- 20. Amateur Radio was no longer visible as part of one of the fourteen different categories of the Radio Spectrum Policy Program. A letter to Commissioner Neelie Kroes finally opened the door to the commission specialist on spectrum. In a talk with him it was agreed with that G6JYB will present the amateur interests to the Radio Spectrum Committee.
- 21. New technology developments are being monitored. For example Smart Grid is not (yet) dangerous for spectrum usage. Policy on wireless power transfer (for electric cars and busses) will keep us busy next term.

ITEM 5: HF COMMITTEE

22. <u>HF Manager.</u> Ulrich, DK4VW, presented the HF Report (EC14_05). Main concerns are harmonisation of the 40 metre band with Regions 2 and 3 and the response from member societies on the national status of the 160 metre band.

ITEM 6: VHF/UHF/MICROWAVE COMMITTEE

- 23. <u>VHF/UHF/Microwave Manager.</u> Michael, OE1MCU, discussed the VHF report. (EC14_06). Main concern is the pressure on microwave spectrum.
- 24. OE1MCU has indicated that he will be stepping down at the Region 1 General Conference.
- 25. Internal C5 discussions in preparation of the general conference are facilitated by using a closed wiki.

ITEM 7: WORKING GROUPS

- 26. <u>ARDF.</u> LZ1US presents the report (Paper EC14_07.1 and 07.1a). ARDF WG proposes a change to the Terms of Reference; the EC decides that the proposal will go forward to the General Conference. The EC appointed PA Nordwaeger, SM0BGU, for the chairman of the International Jury of the World ARDF Championships and Panayot Danev, LZ1US, as chairman of the International Jury of the Youth ARDF Championships.
- 27. <u>ARSPEX.</u> 9A5W presents the report (EC14_07.2). Gaston has indicated that he will not stand for re-election.
- 28. <u>EMC.</u> DL9KCE presents the report (EC14_07.3) and highlighted the various CISPR committees and the work done.
- 29. <u>EMERCOM.</u> LZ1US presents the report (EC14_07.4). G0DUB to meet Commissioner Georgieva at the General Conference. It is noted that Global SET loses in popularity. GAREC was well attended with an interesting program.
- 30. <u>HST.</u> LZ1US presents the report (EC14_07.5). The EC appoints Oliver Tabakovski, Z32TO, as chairman of the International Jury for the Region 1 HST Championship. No suitable software package has been

found to support HST and ARDF events.

- 31. <u>IARUMS.</u> 9A5W presents the report (EC14_07.6). The EC complements the Region 1 Monitoring System on the work. The EC has a concern about over the horizon radar. It was decided that LZ1US will approach the Russian administration about taxis on the 10 metre band.
- 32. <u>IPHA.</u> SM6CNN presents the report (EC14_07.7). Liaison with Youth co-ordinator to involve IPHA activities. The GC to decide if we want to continue with a separate coordinator.
- 33. <u>Regulatory Affairs.</u> G3PSM presented the report (EC14_07.8). Negotiations with Japan regarding T/R 61-01 continue. The ECO website provides a link to the document *Ethics and Operating Procedures for the Radio Amateur*.
- 34. <u>STARS.</u> PB2T presents the report (EC14_07.9). It is felt that more STARS activities could be deployed.
- 35. <u>Youth.</u> PB2T presents the report (EC14_07.10). Nominations for the Outstanding Ham Youth Award are sent to PA2LS. The EC approves funding of ZS6YH to attend YOTA. PB2T will attend YOTA on behalf of EC.
